## 1. Organization

The Japan Mountain Bike Cup Executive Committee is the organizer of the UCI Japan Mountain Bike Cup Expo.

# 2. Application

a) Exhibitor applications must be submitted by September 30th through the official online form.

b) Exhibits must be clearly marked.

c) Products not listed on the exhibitor application form may be rejected by the organizer.

d) By applying to exhibit, the exhibitor agrees to the Exhibit Terms and Conditions without reservation.

## 3. Cancellation/Modification

a) Exhibitors who wish to cancel their exhibition must pay the following compensation amount. Expenses associated with withdrawal shall be billed to the relevant exhibitor.

August 1st to August 31st 25% of the exhibition fee From September 1st to September 30th 50% of the exhibition fee From October 1st to October 28th 100% of the exhibition fee

b) Exhibitors may not use booths assigned by other companies or change booth locations with other companies without the consent of the Organizer.

4. Booth

a) Advertising spaces (such as advertising banners) may only be placed on the booth itself (inner and outer walls).

b) Advertising materials may only be distributed within the booth.

c) Exhibitors shall be allocated parking spaces. Scheduled for the side and back of the booth.

d) Booth subleasing, displaying or selling merchandise inappropriate or irrelevant to the event is not permitted.

e) Marquees may not be fixed to the ground with nails/pegs (tarred surface). They can only be fixed in place with weights.

f) determination of position;

The final booth position will be decided near the start/finish area, comprehensively considering the exhibit size, exhibit products, usage of the test drive course, etc., and will be notified by mid-September. Exhibitors are not allowed to make complaints or request cancellation of their booth position.

# g) sale of goods;

Merchandise sales within the booth are permitted. Food and drink must be separately reported to the public health center, etc. The organizer will not be held responsible for any troubles associated with sales activities.

#### 6. Payment

Booth fees must be paid within 10 days of receipt of the invoice and must be paid in full by the day before the event (October 27th). Access to the booth will not be granted without payment confirmation. If payment cannot be confirmed, the exhibition application will be automatically cancelled.

### 7. Liability/Insurance

The organizer shall not be held responsible for any damage or theft of products owned by exhibitors, or any injury, damage or theft of participants during the test drive.

### 8. Change/Cancellation of Event

In the event of unavoidable reasons, especially force majeure (bomb alarms, earthquakes, severe weather, etc.), the organizer reserves the right to postpone or shorten the competition, temporarily or completely close it, or cancel the exhibition venue. In this case, we will reimburse the exhibitor for the rest of the exhibition fee, excluding the expenses required for the preparation of the exhibition and the cancellation fee for the use of the exhibition hall, etc., but we will not be responsible for any expenses or damages incurred by the exhibitor.

#### 9. Place of Jurisdiction

The place of jurisdiction for all disputes relating to the UCI Japan Mountain Bike Cup Expo shall be Izu City, Shizuoka Prefecture.
